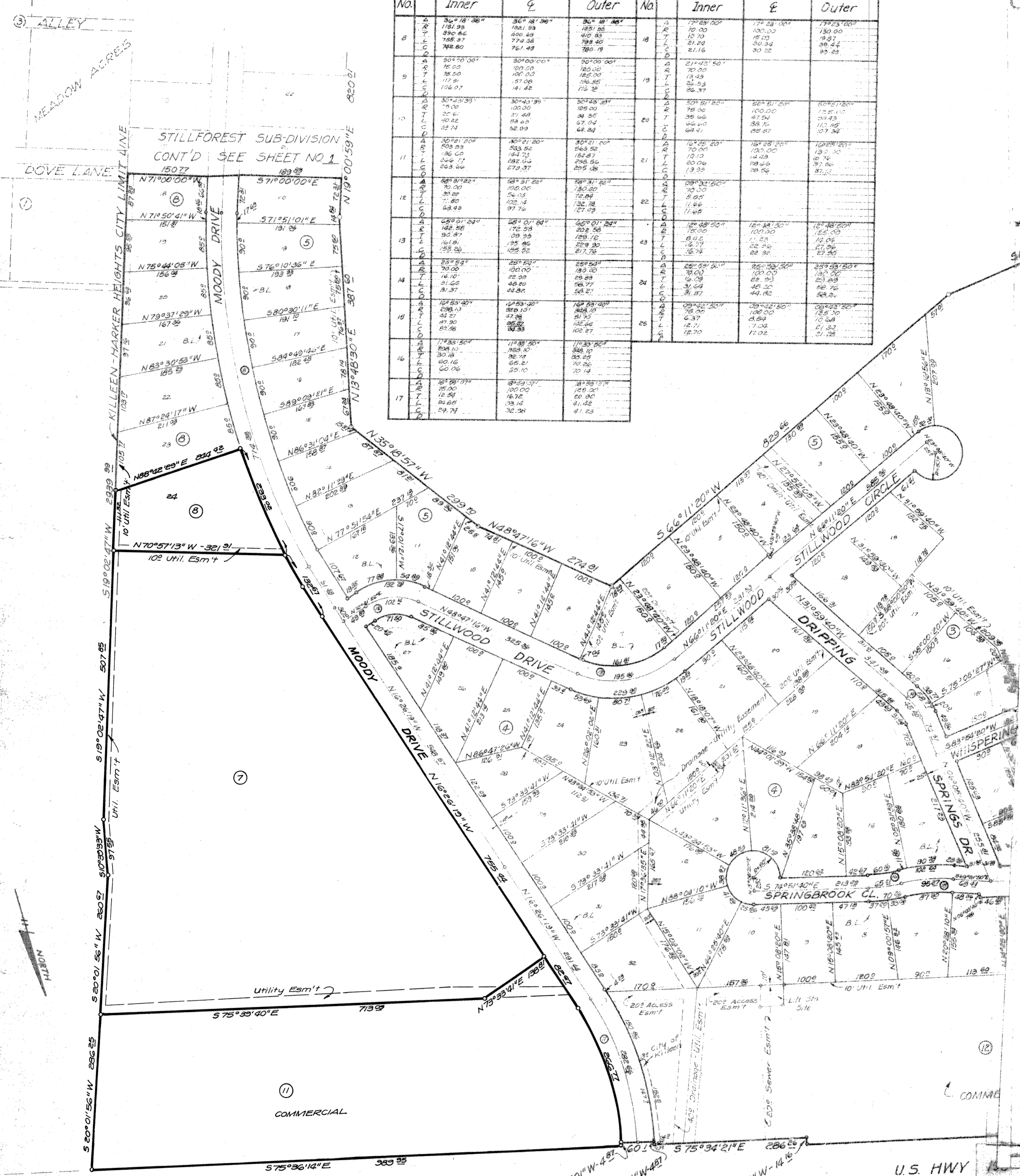

KNOW ALL MEN BY THESE PRESENTS that Cobell, Inc. whose address is 808 Oakhill Drive, Killeen, Texas, acting by and thru its duly authorized officers, being the sole owner of that certain 126.23 Ac. tract out of the John H. Jasper Survey, Abst. No. 590, and the J.J. McGofflin Survey, Abst. No. 623, Killeen, Bell County, Texas, which is fully described in the dedication of Stillforest Subdivision, does hereby resubdivide a portion of said land into lots and blocks to be known as a portion of Stillforest Subdivision as shown by the plat hereof, and attached hereto, and made a part hereof, and approved by the City Council of the City of Killeen, Texas, Bell County, Texas and Cobell, Inc. does hereby adopt said plat of Stillforest Subdivision as an addition to the City of Killeen, Bell County, Texas, and for the purpose of selling lots and blocks of land with reference thereto and for all other purposes; and do hereby dedicate to the City of Killeen all streets, avenues, roads, drives, and alley shown on said plat, the same to be used as public thoroughfares and for the installation and maintenance of public utilities when and as authorized by the City of Killeen. The utility easements shown on said plat are dedicated to the City of Killeen for installation and maintenance of any and all public utilities, which said City may elect to install and maintain or permit to be installed and maintained.

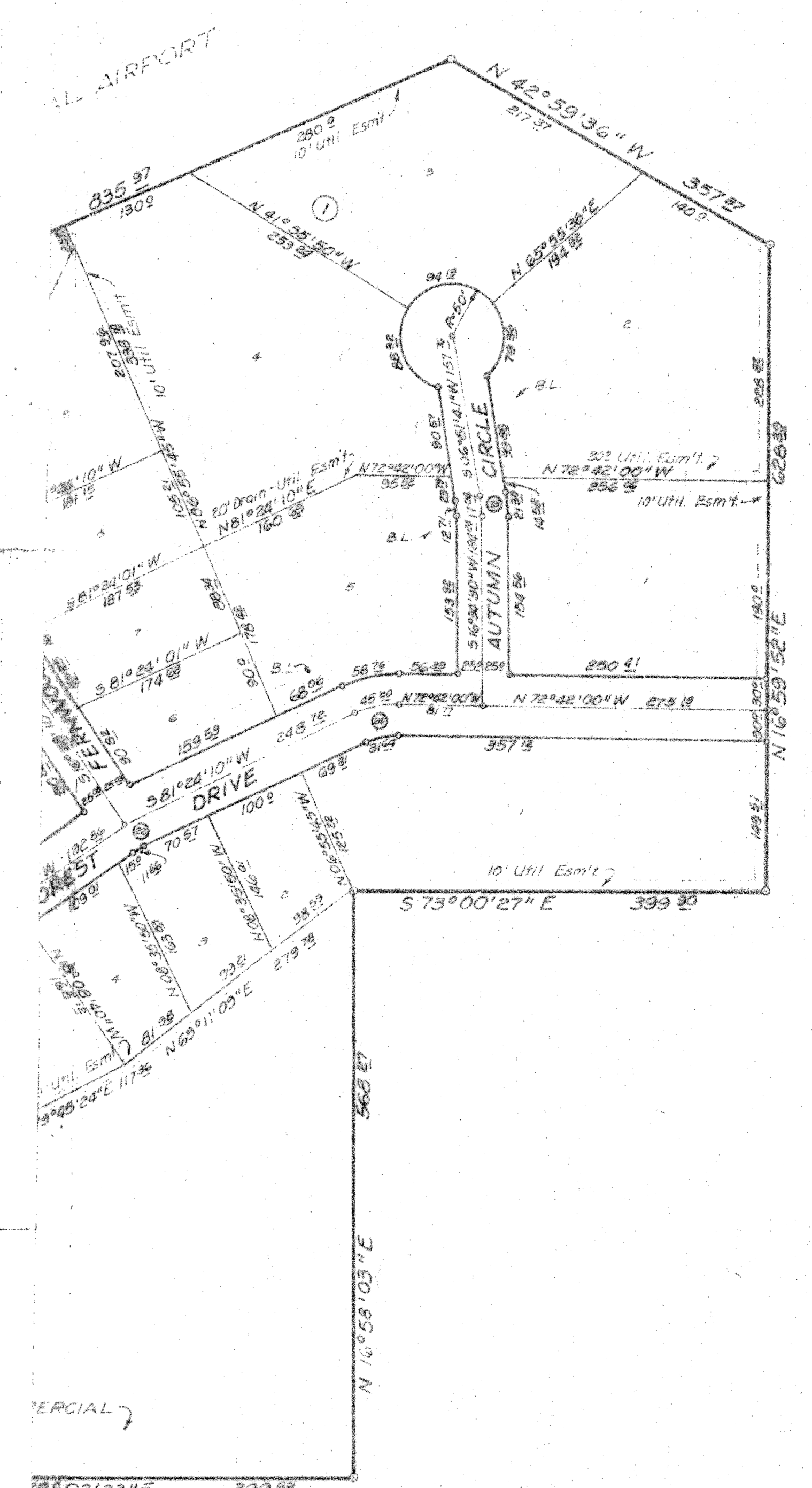
