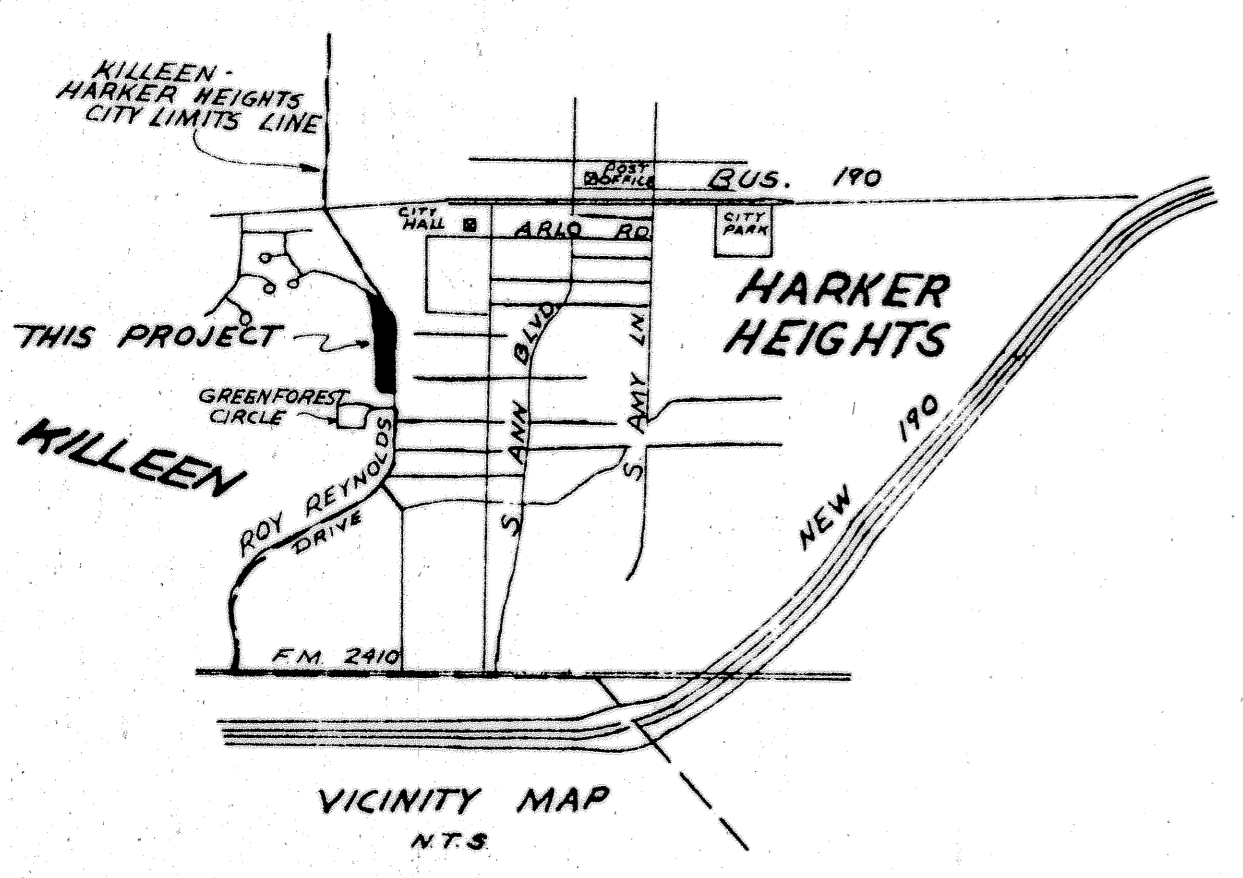


NOTE All Easements 10' Off Property Line Except As Noted.



KNOW ALL MEN BY THESE PRESENTS, that COBELL, INC., whose address is P. O. Box 666, Killeen, Texas, acting by and through its duly authorized officers, being the sole owner of that certain 6.298 acre tract out of the John H. Jasper Survey, Abstract No. 990, Bell County, Texas, which is fully described in the dedication of Stillforest Sub-Division does hereby Re-Subdivide said land into lots and blocks to be known as the Replat of Block 5, Lots 13-28, Stillforest Subdivision, as shown by the plat hereof, attached hereto, and made a part hereof, and approved by the City Council of the City of Killeen, Bell County, Texas, and Cobell, Inc., does hereby adopt said replat of Stillforest Subdivision as an addition to the City of Killeen, Bell County, Texas, and for the purpose of selling lots and blocks of land with reference thereto and for all other purposes; and do hereby dedicate to the City of Killeen, all streets, avenues, roads, drives, and alleys shown on said plat, the same to be used as public thoroughfares and for the installation and maintenance of public utilities when and as authorized by the City of Killeen. The utility easements shown on said plat are dedicated to the City of Killeen for installation and maintenance of any and all public utilities, which said City may elect to install and maintain or permit to be installed and maintained.

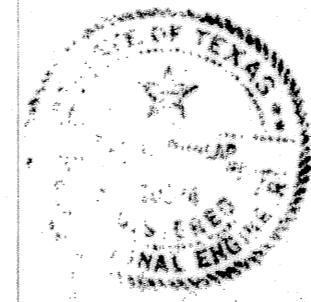
