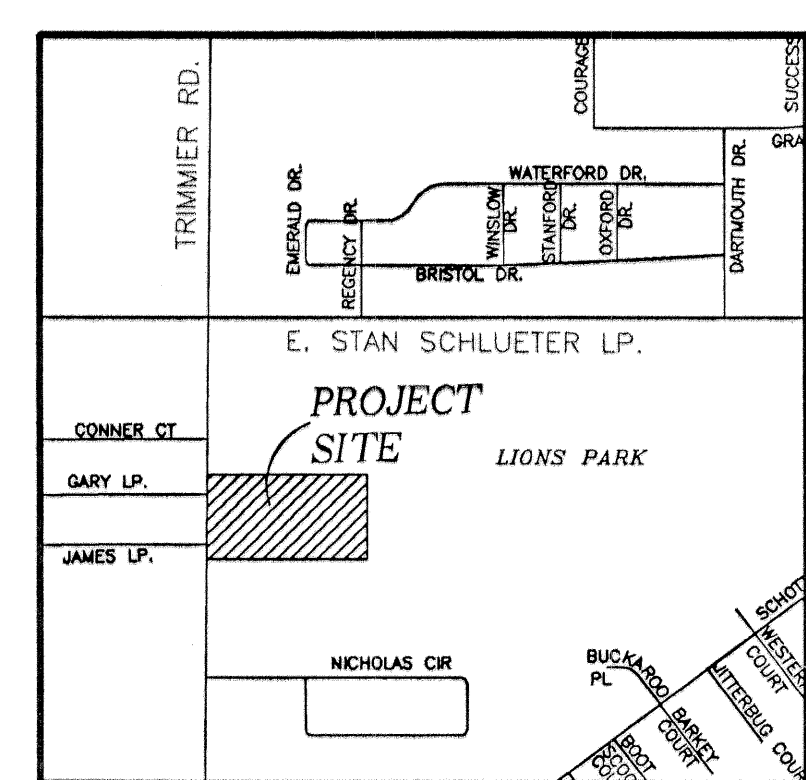


INSET 'A'

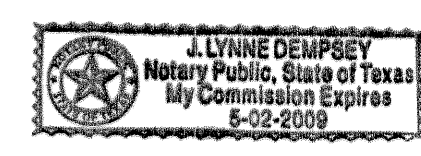

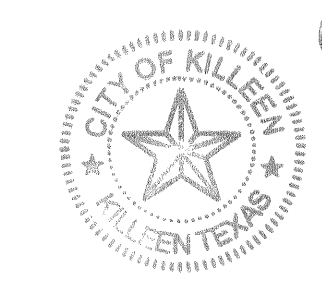

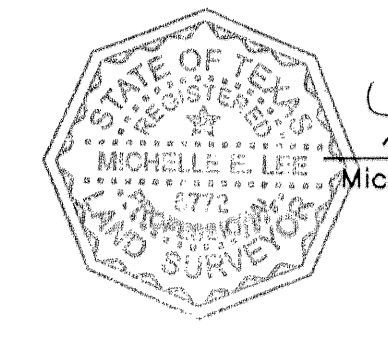
