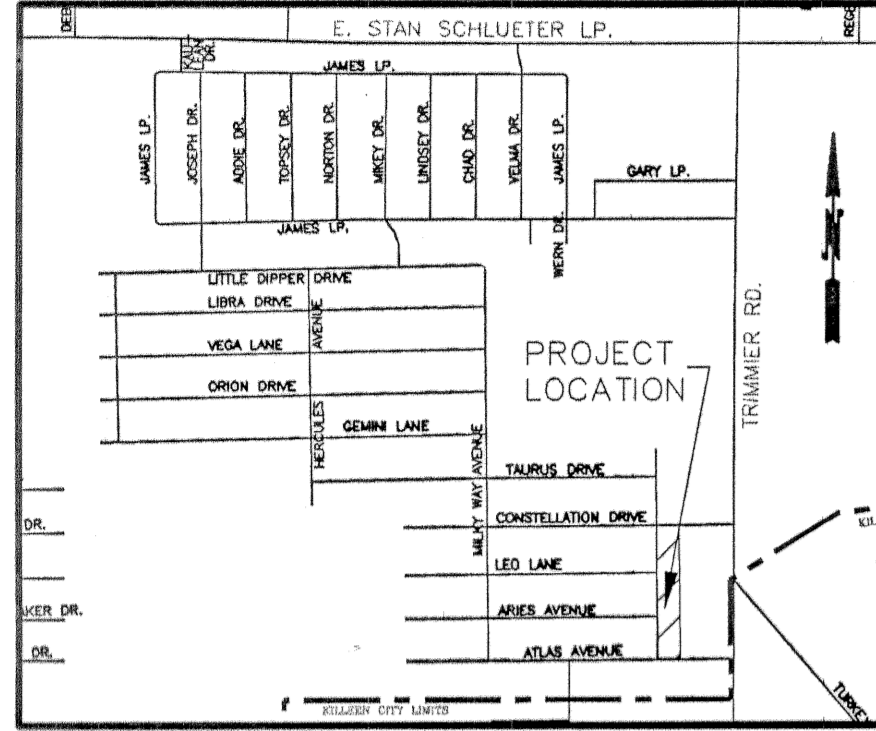
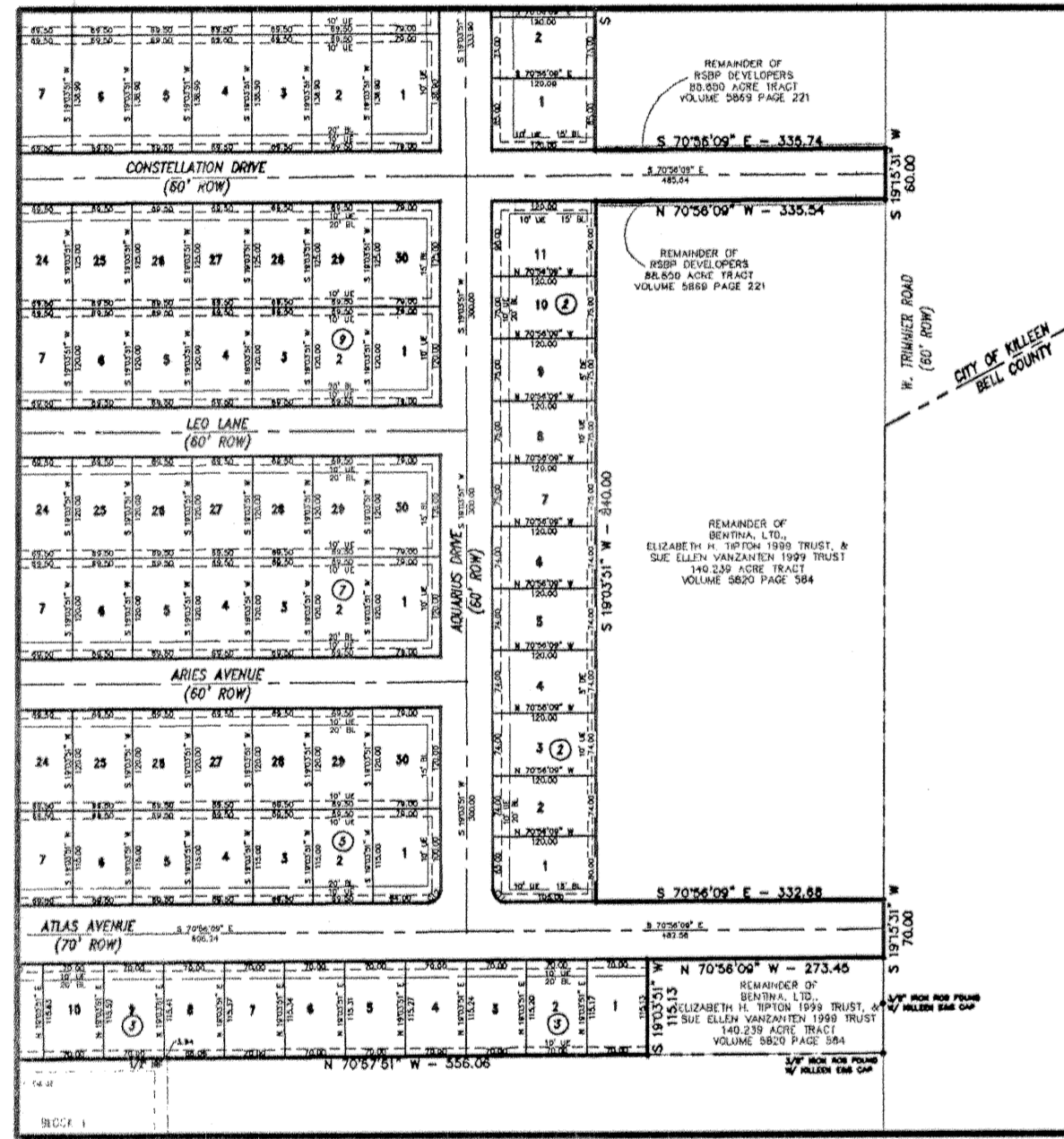

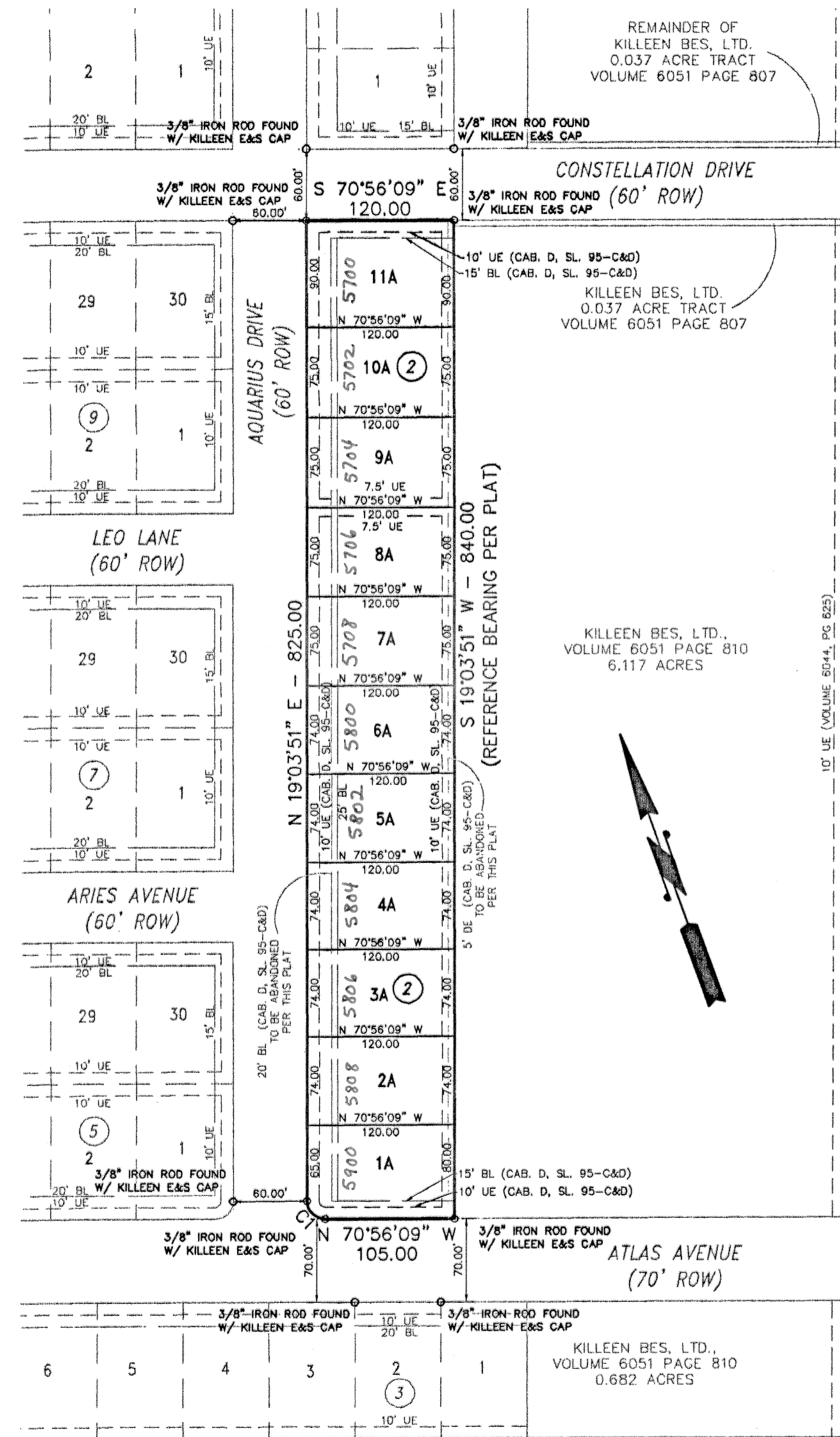


VICINITY MAP

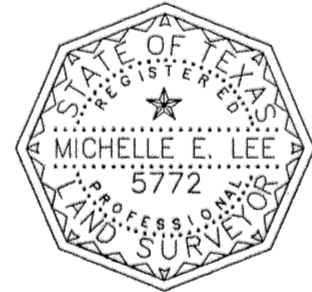
