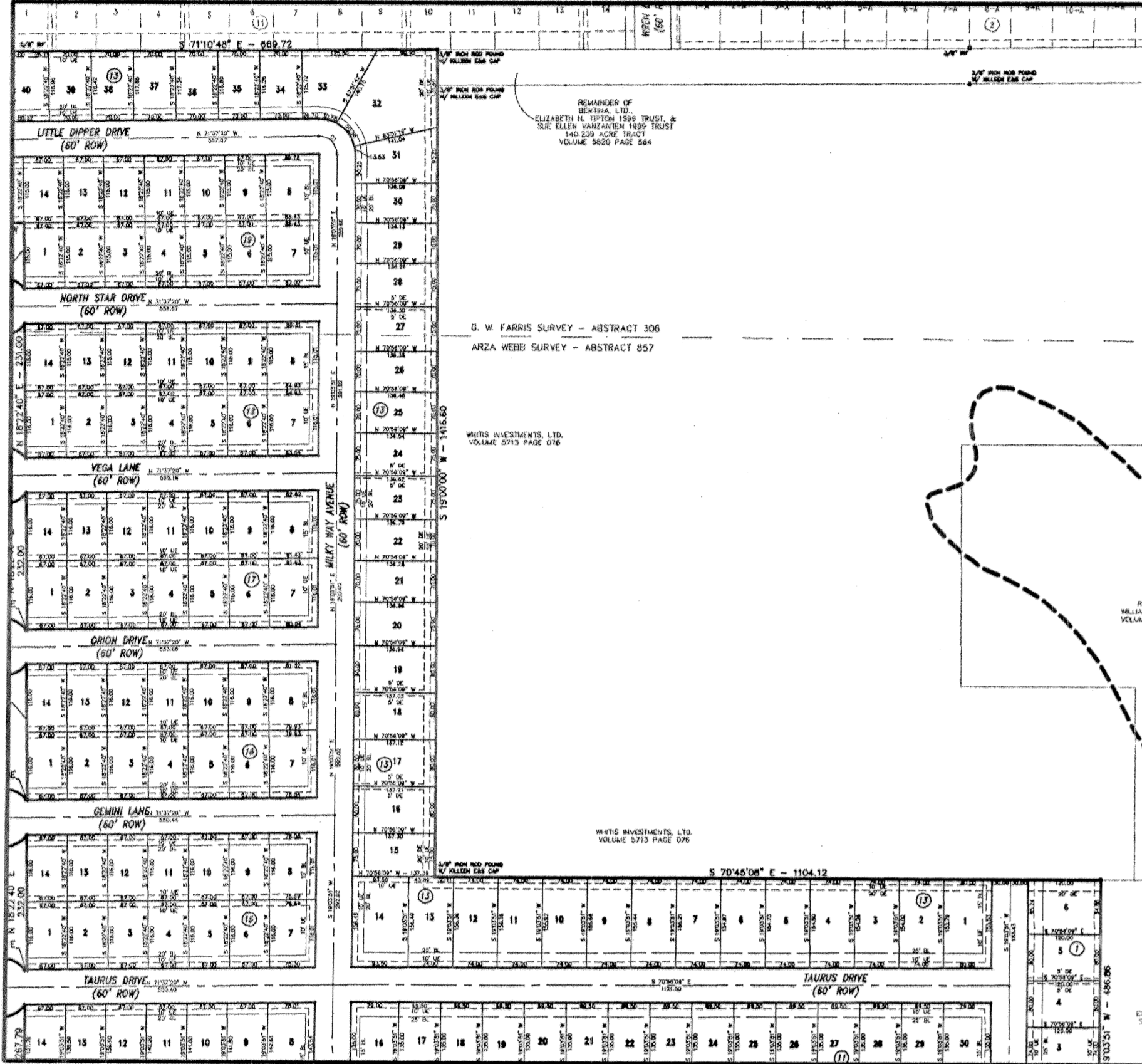


Notes: Unless otherwise noted hereon, all subdivision perimeter corner monuments are 3/8" iron rods with orange caps marked "KILLEEN E&S".

Utility Note: All Utilities within the easement along the rear of Block 13 shall be underground utilities.

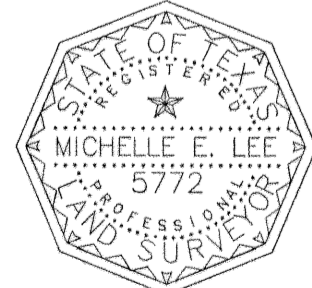


INSET 'A'
