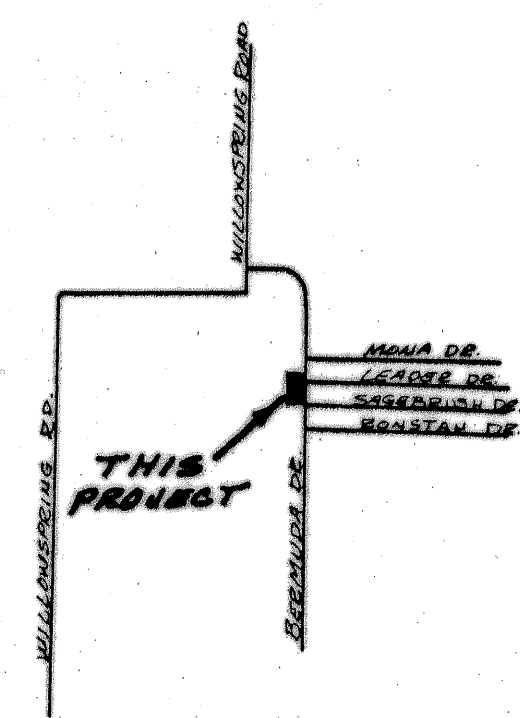
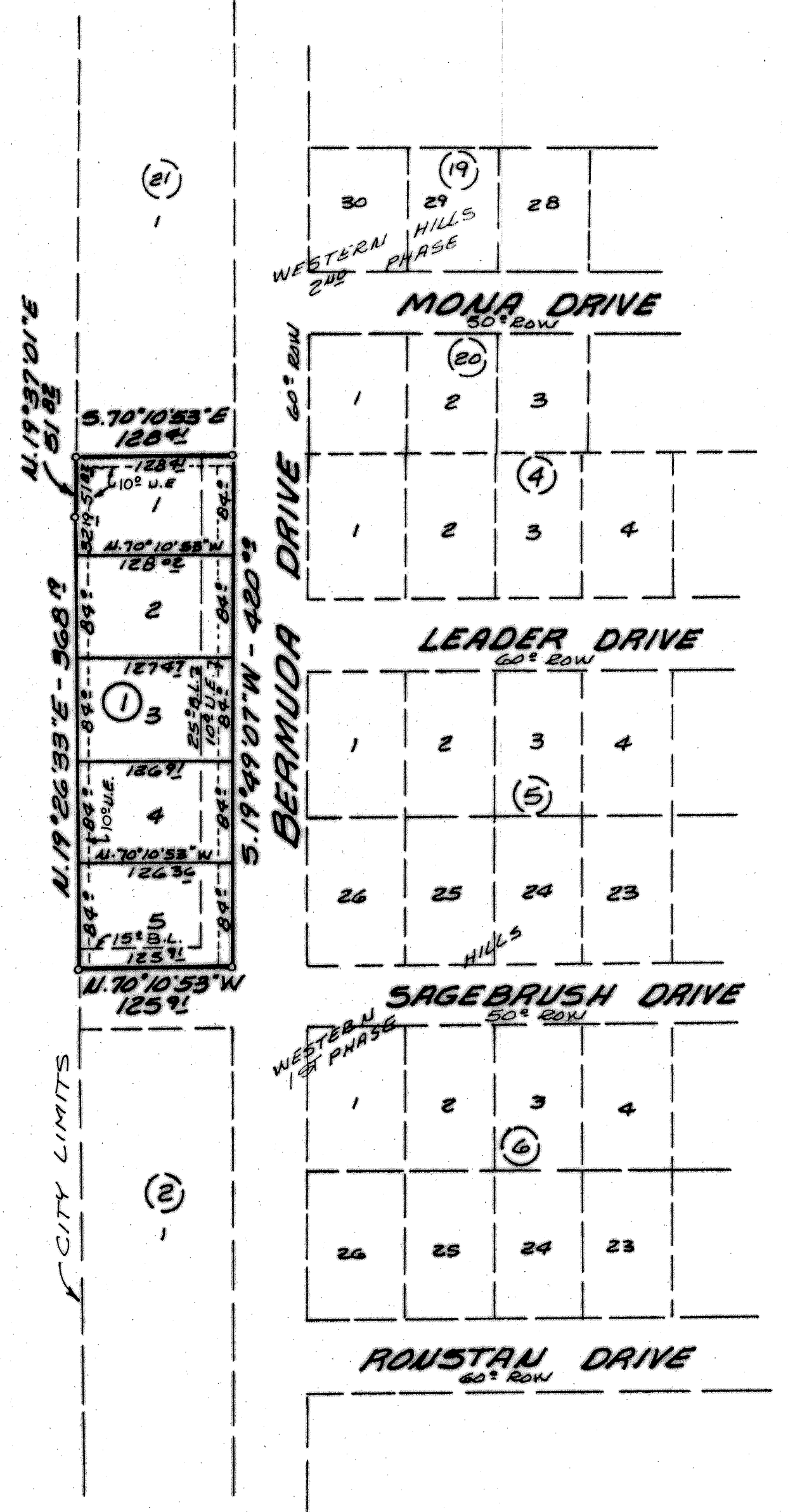


PURSER ET AL TRACT

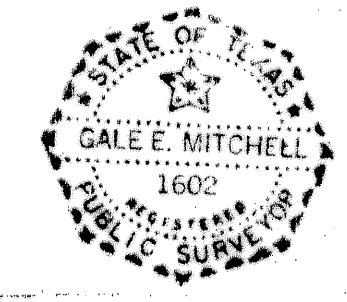
