


Note: All easements shown are 10' wide at rear



Beginning at the southeast corner of Block 25 lot 1, Willowbend 1st Unit, Addition to the City of Killeen, Bell County, Texas.

Thence, N72°21'28" W, 173.5 feet to an iron pin for the southwest corner of Willowbend, 1st Unit, Addition to the City of Killeen, Bell County, Texas.

Thence, S19°42'59" W, 432.2 feet and S19°42'59" W, 83.48 feet, along the west line of Mary A. Price tract to an iron pin for the southeast corner of this.

Thence N70°04'45" W, 609.07 feet, along the north margin of Lake Road to an iron pin.

Thence N19°25'38" E, 206.86 feet, along the east line of the Girl Scout tract to an iron pin.

Thence NE89°56'56" W, 410.64 feet, to the northwest corner on 0.99 acre tract of conveyed to the City of Killeen by Jim B. Bundrant et ux in a deed of record in Vol. 858, Pg. 207, Deed Records of Bell County, Texas.

Thence, N19°33'41" E, 0.70 feet, to the northeast corner of an 0.99 acre tract conveyed to Opal Horn from Jim B. Bundrant et ux in a deed of record in Vol. 994, Pg. 105, Deed Records of Bell County, Tex.

Thence, N69°49'05" W, 208.70 feet, along the north line of said Opal Horn tract to an iron pin for the northwest corner of said tract.

Thence, S19°33'41", 208.7 feet, along the west line of said Opal Horn tract to an iron pin in the margin of Lake Road.

Thence, N69°49'05" W, 275.60 feet, to an iron pin for southeast corner of this.

Thence, N19°42'59" E, 1372.50 feet and N19°21'22" E, 908.24 feet, to an iron pin for the northwest corner of this.

Thence, S83°43'05" E, 889.79'; S22°26'13" E, 551.79'; S19°42'57" W, 90.0'; S78°16'54" E, 91.13'; S22°26'13" E, 41.26'; S19°42'59" W, 137.72'; S78°16'54" E, 113.31'; S22°26'13" E, 46.20'; to an iron pipe for the most easterly northeast corner of this.

Thence, S19°21'49" W, 410.34' and S19°22'38" W, 186.75' and S70°37'22" E, 88.68' to an iron pipe.

Thence, along a curve to the left, Rad. = 372.29'; 75.00' to an iron pin for the northwest corner lot 1, Blk 21, Willowbend, 1st Unit, Addition to the City of Killeen.

Thence S18°03'28" W, 406.52 feet, to the point of beginning.

Does hereby subdivide said land into lots & blocks to be known as WILLOWBEND ESTATES as shown by the plat hereof, attached hereto and made a part hereof, and approved by the City Council of the City of Killeen, Bell County, Texas and Kenneth L. Kirkpatrick et ux does hereby adopt said plat of WILLOWBEND ESTATES as in addition to the City of Killeen, Bell County, Texas, and for the purposes of selling lots & blocks of land therefrom thereto, and for all other purposes, and do hereby dedicate to the City of Killeen all streets, avenues, roads, and drives and alleys shown on said plat, the same to be used as public thoroughfares and for the installation & maintenance of public utilities, when and as authorized by the City of Killeen. The utility easements shown on said plat are dedicated to the City of Killeen for installation & maintenance of all public utilities, which said city may elect to install and maintain or permit to be installed and maintained.
